

## Setting up your Digital Audio Baby Monitor

#### A. Baby unit power supply



- · Insert the DC plug of the power adapter into the DC jack on the side of the baby unit, as shown.
- Connect the other end of the power adapter to a suitable mains power socket.
- The Power indicator will illuminate.

Only use the power adapter provided (DC6V/400mA).




#### WARNING:

#### B. Parent unit power supply



- Insert the DC plug of the power adapter into the DC jack on the side of the parent unit.
- Connect the other end of the power adapter to a suitable mains power socket,
- · The parent unit will turn on.

#### NOTE

Only use the power adapter provided (DC6V/400mA).

### Basic operation of the keys

ტ	Press and hold to power on/off the parent unit.	
•	Press to decrease speaker volume. A long beep will be heard when press down to mute the speaker*.	
•	Press to increase the speaker volume.	
Baby Unit		
ტ	Press and hold to power on/off the baby unit.	

<sup>\*</sup>Note - When speaker is muted, a sound alert beep will be heard on the parent unit when sound is detected from the baby unit.

## Parent unit battery installation

As an option, the Parent Unit can be powered by alkaline batteries (Size AAA x 2, NOT included), so that it continues to work if you disconnect it from the mains power to carry it to another location. Please follow the steps below to install alkaline batteries.





Open and lift the battery door up as shown in the figure. (fig.b1)

Insert the alkaline batteries follow the direction into battery compartment. (fig.b2)

Insert the catches at the top of the battery door then close the door as shown in the picture. (fig.b3)
